WATER HEATER PROTECTION PROGRAM

SIGN-UP & PAYMENT AUTHORIZATION

Program participation requires a one-time \$10.00 sign-up fee and \$6.99 per month.

SERVICE AGREEMENT: Blue Ridge Mountain EMC will maintain my electric water heater(s) in operating condition by repair or replacement of the water heater or water heater components but shall not be responsible for indirect, unforeseen or consequential damage (i.e. flooding, fire, etc.) caused by my water heater or its components or for repair resulting from the intentional or negligent misuse of the water heater, or acts of God (ie: dry firing of elements, lightning strike, etc). I agree to supply access to the water heater and reasonable working area. I may stop this service agreement at any time **before** maintenance work has been done at my home at no further cost to me. I understand that I will not be reimbursed for monthly coverage already paid should I decide to cancel the coverage. After a water heater has been installed or my existing unit has been repaired, I agree to remain on the Water Heater Program for a full 72 months **thereafter** (unless I have been on the program for at least 7 years prior to the service call), or I may cancel this agreement by paying the full cost of the labor and materials used in the replacement or repair. **Blue Ridge Mountain EMC reserves the right to cancel coverage with 30 days written notification and billing will stop.** Coverage will not begin on my existing water heater(s) until 30 days from receipt of this application by Blue Ridge Mountain EMC. Water heater **MUST** be in working condition at the time of sign-up.
