## 4. FIRST AID MEASURES

### 4.1 Description of First Aid Measures

General Advice: Get medical attention if symptoms occur.

- Eye contact:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Clean surface thoroughly to Remove residual contamination. Never return spills to original containers for re-use.

## 7. HANDLING AND STORAGE

### 7.1 PRECAUTIONS FOR SAFE HANDLING:
